

CERTIFICATE LICENCE – LABOUR CONTRACT

Line 1.

Soke Žiko G. Bečanović 10^odan is the president of Global Karate Federation HACHI-O-KAI MARTIAL ARTS Europe after the existing licence and the above-mentioned is the only representative of GKF HACHI-O-KAI MARTIAL ARTS EUROPE.

The new licence, labor contract for the period of 2012-2020 will give the right to Soke Žiko G. Bečanović 10^odan to implement plans, programs, complete organisation of GKF HACHI-O-KAI MARTIAL ARTS EUROPE in Europe and agreed destinations in world. He will get every authority included in the Statute of the European Federation.

Line 2.

President Soke Žiko G. Bečanović 10^odan, Nušićeva 2, Subotica, Serbia, Europe will organise:

- Seminars
- Joint trainings
- Preparation for examinations for instructors, referees and black belts and exams for black belts 1-10^odan in Europe and agreed destinations in world.
- Competitions, European Karate Cups, seminars for referees, European and World Karate and Martial Arts Championships (judo, aikido, karate, jiu-jitsu)
- Schools for selfdefence and security guards through universities in Canada, USA
- Diplomas, certificates, licences

All this programs will implement together:

Soke Takemasu Okuyama 10^odan (Japan – World) and

Soke Žiko G. Bečanović 10^odan (Serbia) – Europe

This powers are non-transferable and in the name of European and World Association through this certificate Soke Žiko G. Bečanović 10^odan is empowered to implement this rights.

Line 3.

Any misuse of the name GKF HACHI-O-KAI MARTIAL ARTS Europe and World subjects to sanction and penalty, according to members of the statutes of the Federation 50, 51, 52, 53, 54, especially for the issue of black belts 1-10^odan, diplomas for referees, instructors (for these only the Federation can give numbers).

Line 4.

Penalties from the previous article, and pursuant to statute and the level of irregularities, determines the Presidency of the Federation.

Line 5.

The authorization to work in GKF HACHI-O-KAI MARTIAL ARTS will determine the representative of World Federation Soke Takemasa Okuyama 10^odan and and the representative of European Federation Soke Žiko G. Bečanović 10^odan. They are the only authorized people in this association.

Line 6.

License-agreement made in four identical copies, two for World and two for European Federation.

Line 7.

In case of dispute decisions made by the competent courts.
